Although the government's flagship 1D1F is supposed to help address these challenges, it has been very slow. Investors interested in agro-processing may stand the chance of accessing some credit with government guarantee.



Agricultural Input Production

With the increasing consumer awareness, organic foods are likely to have a high demand in the immediate years. Studies suggest consumers are willing to pay up to 50% more for foods produced organically. Access to organic fertilizer to boost production currently is non-existent in Ghana. Investors can leverage on government's one-district-one-factory (1D1F) initiative to enjoy tax holidays over a period of time.









RENEWABLE ENERGY PRODUCTION & SUPPLY

Solar energy

Investing in the supply and installation of solar panels is a viable business opportunity. The cost of energy in Ghana creates a significant demand for alternative sources of power.



Bioenergy Production

Biomass, such as agricultural residues and organic waste, can be used to generate electricity and produce biofuels. Businesses can invest in biomass power plants and biogas production facilities. Apart from reducing the cost of energy, it will also provide a safe and environmentally sustainable source of energy for both domestic and industrial use.

Medical Services




Telemedicine (telehealth)
